The Challenges Faced by International Companies Inspire Us



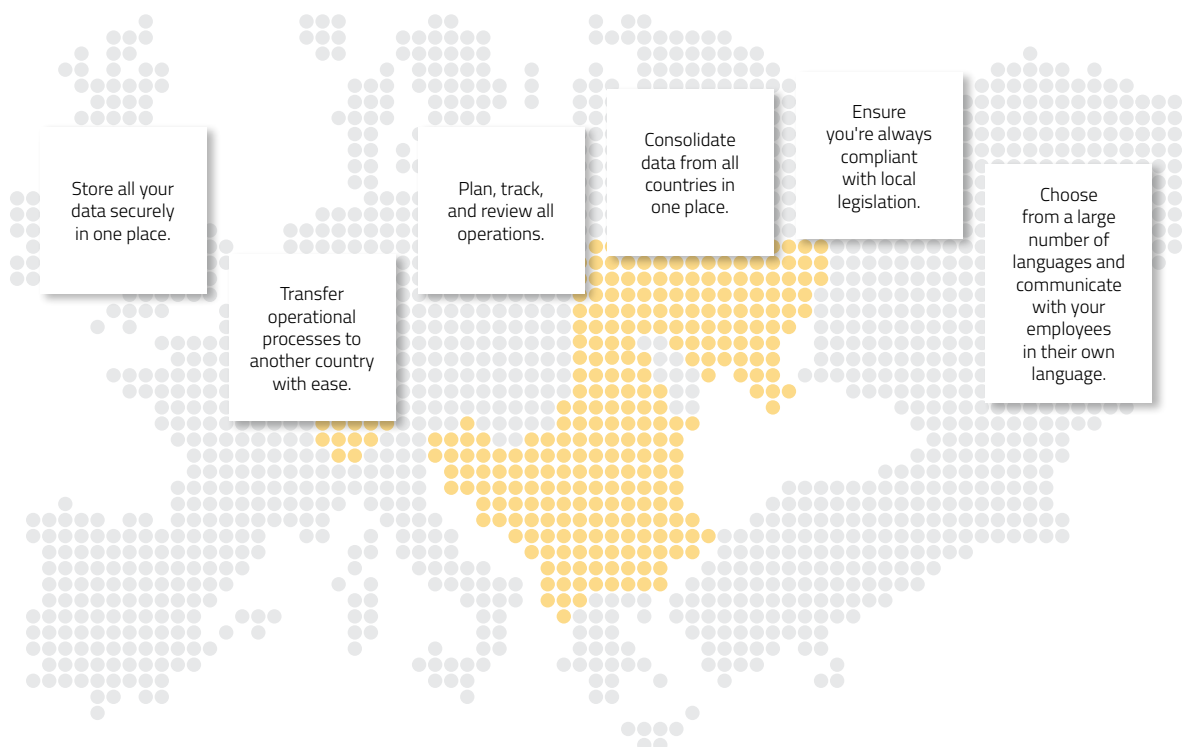

Planning and Analyses

Planning cash flow and revenue by department is important for all companies. Centralized Administration (Users, Databases, Upgrades)

Company Registers

Using company registers, you can fill and harmonize registers on all databases from just one central database. Additionally, you can automate this entire process. Example: When the parent company adds new price lists, items, or products, all subsidiaries receive the date to their databases automatically.

Billing between Countries

Billing between companies in a group is made simpler and faster if the ERP system supports importing documents as e-invoices. Simplifying the billing process between companies and related companies eliminates errors that could otherwise appear in the chain of issuing an invoice.

Transfer Employees within Companies

A good ERP allows you to see all employees in the group of companies and simply transfer an employee from one of the companies to another, eliminating the lengthy process of creating a new user, assigning permissions, etc.

Manufacturing Material Requirements

When larger manufacturing operations are split among different plants (in the same country or different countries), you will eventually need access to information about material inventory, its accessibility, and to check on currently active work orders, their status as well as their planned completion. Modern ERP software must support all these features.



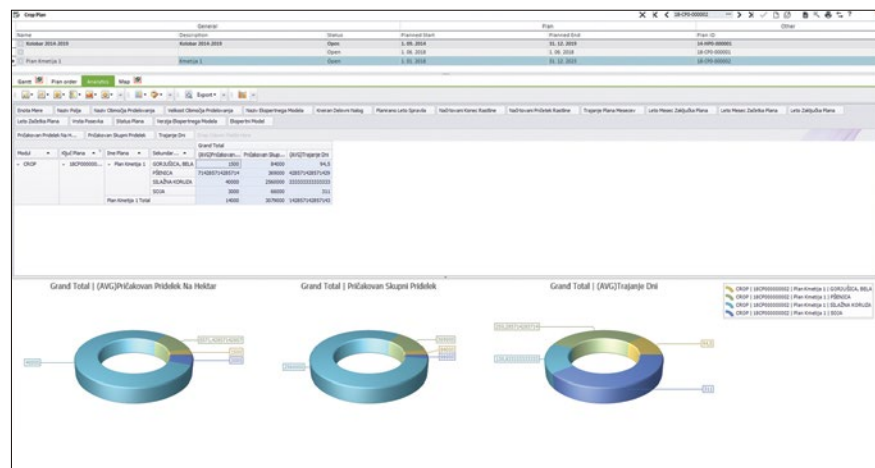
Based on the annual plan of its subsidiaries, the parent company can easily compile a financial plan for the entire group.
